

2020 was a challenging year - including for judicial training. The essence of the European Judicial Training Network's (EJTN's) training activities is to build and deepen mutual trust by bringing together judges and prosecutors from all over Europe, to enable them to meet in a protected physical space to discuss legal and other issues face to face. This normality was no longer possible for the majority of 2020. The Covid-19 pandemic brought a sudden end to all cross-border meetings and training activities. However the EJTN and its members reacted quickly. With very few exceptions, EJTN moved all seminars into the virtual space. The high degree of flexibility and strong will of the EJTN's members, trainers, activity coordinators, and participants enabled this move. I would like to thank them all for their tremendous contribution!

The strong will to continue, to stay operational, is the reason why I can proudly present a calendar of training activities for 2021. This calendar is an expression of hope that we can implement most of our activities in the way in which we are used to doing so – in person. It simultaneously provides the flexibility to hold all activities online, as in 2020: all seminars in the first quarter of 2021 will be held in the virtual space as webinars. We shall keep assessing the sanitary developments closely thereafter and go online if necessary. All seminars in 2021 are planned from scratch with an alternative online option.

As usual, the EJTN 2021 offer is designed to address the interests and needs of European judges, prosecutors, judicial trainees and trainers from across Europe regarding training on EU law, the Rule of Law, judgecraft, training methodologies, linguistics and societal issues.

EJTN's activities are the outcome of the cumulative efforts of the EJTN's Members, encompassing all national training institutions from all 27 EU Member States and the Academy of European Law (ERA), with the objective of shaping the future of European judiciaries. They are built on an extensive analysis of

training needs including an evaluation of past events. These needs are expressed by the EJTN's Members, participants of the EJTN's activities, numerous partner organisations, including judicial networks and associations, as well as the European institutions and EU Council Presidencies.

I am grateful to everyone involved in the development and performance of activities: EJTN Member institutions, Working Group Programmes and its four Sub-Working Group members, members of the Working Group Judicial Training Methods and Working Group Linguistics, as well as all their conveners, activity coordinators, experts and project managers of the EJTN Secretariat.

Please find attached an overview of the EJTN's broad range of training activities, as well as information on how, when and where to apply. I encourage everyone to take part in the seminars presented, as well as other training opportunities and to further disseminate information about the EJTN's training activities.

This calendar also presents an increased EJTN e-training offering, the EJTN's database of materials and resources, and an English language self-test. Please note that the EJTN flagship activity, the Exchange Programme, is not presented in this calendar. Likewise, the topics of the recently launched series of lunch webinars will not be found here, as they are planned at short notice as a response to the most recent developments.

Finally, I would like to express my gratitude to the European Commission for its financial support for the EJTN that made it possible to offer such a rich array of judicial training opportunities.




An online English language level test is now available on the EJTN website:
