What is the aim of the national training programs on the EU acquis?

- Support the establishment of a national network of experts on EU law in Montenegro and Serbia
- Raise awareness of importance and utility of EU law for national judges and prosecutors
- Develop high-quality and sustainable materials compatible with e-learning
- Tailor to Montenegrin and Serbian needs by considering approximation of national law to EU law

Judicial professionals in Montenegro and Serbia interested in becoming experts on EU law

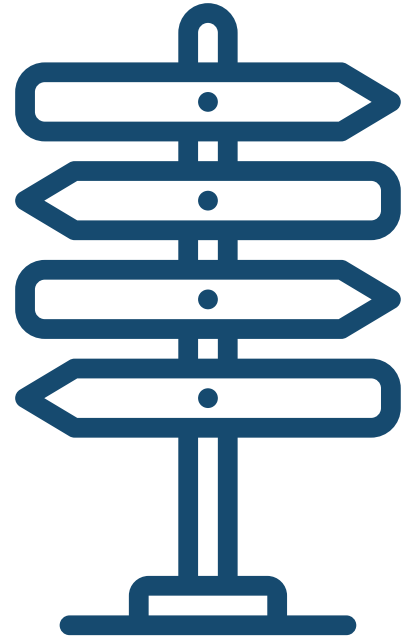
## Why train experts on EU law ?

# How do we train experts on EU law?



- **Roadmap on EU acquis**

Each training first provides a “snapshot” of EU competencies in a broad area of law (e.g. criminal) giving direction for future development of EU law courses



- **with support from EJTN Experts**

EJTN Experts work together with judicial trainers in Montenegro and Serbia to design the program



- **Workshops**

Participants learn to find sources of EU law, design judicial writing and case studies workshops, and make appropriate links between EU and national law, with reference to one or more sub-topics of EU law (e.g. environmental crime)



- **high-quality written content**

Training materials incorporate modern e-learning techniques and are available for future use
